## **CRRSAA/ARP Information**

## CRRSAA and ARP

- 1. The Northeast Higher Education District (NHED) consisting of Hibbing Community College, Itasca Community College, Mesabi Range Community College, Rainy River Community College and Vermilion Community College, completed the required certification to receive funding from the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and the American Rescue Plan (ARP) to provide Emergency Financial Aid Grants to Students.
- 2. NHED has received \$1,351,010 of CRRSAA funds that was distributed to students through Emergency Financial Aid Grants for the 2020-2021 academic year. Additionally NHED has received \$5,239,988 in ARP funds for the 2021-2022 academic year.
- 3. As of December 31st, 2021, NHED has distributed \$1,351,010 in CRRSAA emergency grant payments to eligible students through direct grants (\$1,207,700) and application-based grants (\$143,310). As well as distributing \$2,919,247 in ARP emergency grant payments to eligible students through direct grants (\$2,754,300) and application-based grants (\$164,947). For a cumulative total of \$4,270,257.
- 4. In Spring 2021, NHED estimated 1267 students met the eligibility requirements to receive CRRSAA funds. In Fall 2021, NHED estimated 1516 students met the eligibility requirements to receive ARP funds. Remaining ARP funds will be disbursed to students during the Spring 21-22 academic year.
- 5. Approximately 1267 students received CRRSAA funding through direct or application-based grants during the 20-21 academic year. In the Fall of 2021, Approximately 1516 students have received ARP funding through direct or application-based grants.
- 6. Eligibility criteria for CRRSAA/ARP funding was determined based on guidance from the U.S. Department of education and the Minnesota State Colleges and Universities Office of General Counsel.

CRRSAA and ARP direct grants were distributed to students with demonstrated need according to their calculated Estimated Family Contribution (EFC) as determined by their completed Free Application for Federal Student Aid (FAFSA) application that was filed during the academic year that they received the grant.

CRRSAA fund, direct grants of \$580 were distributed to 1267 students with EFCs below \$15,000. Of those students, 948 were Pell-eligible and received an additional supplemental award amount of \$500 for a total direct grant of \$1080.

ARP fund, direct grants of \$1425 were distributed to 1516 students with EFCs below \$15,000. Of those students, 1188 were Pell-eligible and received an additional supplemental award amount of \$500 for a total direct grant of \$1925.

The application-based Student Emergency Fund grants are being prioritized to serve students with exceptional need as related to the Cost of Attendance at the College (tuition, food, housing, health care, and childcare) with awards up to \$1000.

7. Students with exceptional need are encouraged to contact their Financial Aid Office for information on how to apply for the application based CRRSAA/ARP emergency funds.

Students experiencing special circumstances financially, that could affect the outcome of FAFSA results, are encouraged to contact the Financial aid Office to find out if adjustments to income on the FAFSA are possible.
