



## Managing Your Student Account

### What can I use my Student Account (E-Services) for?

- Viewing electronic invoices
- Make a payment
- Sign up for direct deposit
- Update student contact information
- Grant a parent or other proxy rights to your E-Services account
- Opt-in to receive text messages
- Enroll to view your tax form (1098-T) online

### What do I need to do to stay enrolled (registration cancellation (drop) for non-payment)?

- Pay your tuition and fees in full; or
- Make 15% of tuition and fees due for the term or make a \$300 down payment, whichever is less
- Complete a Federal Application for Federal Student Aid (See FAFSA document in this packet)
- Enroll in a NelNet payment plan; or
- Receive an approved deferral from Minnesota North College; or
- Receive an approved waiver, third-party authorization (TAA, Veterans, DRS), or scholarship

**All supporting documents must be on file with the Minnesota North College Business Office.**

### What is a NelNet payment plan?

NelNet is a third-party payment plan that allows you to pay for tuition and fees over time. Tuition payment plans break down your tuition balance into affordable monthly payments. There is no interest, payment options are flexible, set-up fees are affordable, and it's easy to enroll. Use the link below or call to get started with NelNet!

### When must my account be paid in full?

Any portion of your tuition, fees, and other charges to your student account that is not covered by financial aid is your responsibility. Tuition and fees are due on the 25th business day of the term! **For a more detailed list of payment due dates, you can find them on the back of this page.**

## Fall 2025 Key Dates

**July 1, 2025** – First day to enroll in Fall 2025 NelNet payment plan

**August 29, 2025** – Last day for students to meet Fall 2025 registration cancellation condition.

**August 29, 2025** – Last day to receive 100% refund of tuition and fees for students who totally withdraw from Fall 2025 credit courses and last day for free add/drop period

**September 2, 2025** – Registration cancellations for students who do not meet registration cancellation conditions.

**September 22, 2025** – Last day to receive partial refund (25%) of tuition and fees for students who totally withdraw from Fall 2025 credit courses.

**September 25, 2025** – Last day to enroll in a Fall 2025 NelNet payment plan

**September 30, 2025** – Fall 2025 accounts must be paid in full

**October 1, 2025** – Fall 2025 late fees (\$50) applied to student accounts

**October 1, 2025** – Latest date for Fall 2025 registration holds to be placed on student accounts. Holds must be applied before registration for spring term begins.

## Spring 2026 Key Dates

**November 1, 2025** – First day to enroll in a Spring 2026 NelNet payment plan

**January 16, 2026** – Last day for students to meet spring term registration cancellation condition

**January 16, 2026** – Last day to receive 100% refund of tuition and fees for students who totally withdraw from Spring 2026 credit courses and last day of free add/drop period.

**January 20, 2026** – Registration cancellations for students who do not meet registration cancellation conditions

**February 9, 2026** – Last day to receive partial refund (25%) of tuition and fees for students who totally withdraw from Spring 2026 credit courses.

**February 18, 2026** – Spring 2026 accounts must be paid in full

**February 19, 2026** – Spring 2026 late fees (\$50) applied to student accounts

**February 19, 2026** – Latest date for Spring 2026 registration holds to be placed on student accounts. Holds must be applied before registration for Summer 2026/Fall 2026.

**February 23, 2026** – Last day to enroll in a Spring Term NelNet payment plan
